FlowHawk is the only dedicated, secure system that facilitates and documents these processes, eliminating the risk of confidentiality breaches and broken audit trails of legacy operations.

Accessibility: OmniLife Health's cloud platform is accessible anytime, anywhere via personal smart devices using our native mobile applications for Apple iOS and Google Android, or via our web-based application on any modern browser, including Apple Safari, Google Chrome, Mozilla Firefox, Microsoft Internet Explorer, and Microsoft Edge.

**Permissions:** Users are permitted based on institution role, email address, or phone number — all verified through multistep authentication. Users can be managed by local clinical administrators via the admin portal or by local IT department SSO/ADFS configurations.

**Infrastructure:** The application infrastructure is managed externally by OmniLife Health using Aptible's HIPAA-compliant and HITRUST CSF, ISO 27001, and SOC 2 Type 2 certified server and database deployment platforms.

**Assessments:** OmniLife Health leverages third-party partnerships with ProCircular and 360Advantage to perform routine security vulnerability and risk assessments, including penetration testing and auditing for HITRUST CSF, ISO 27001, and SOC 2 Type 2.

**Independence:** The FlowHawk platform is 100% stand-alone and is not dependent upon any integration with or access to privileged networks for databases.
